

Professional DJ Services Terms & Conditions

Please review service terms & conditions thoroughly.

Deposit of 50% of the Total Invoice is required to reserve event date. Services shall not be rendered until 100% of the invoice balance is received.

Remaining balance must be paid in full, prior to the start of the event. If the remaining balance is not paid prior to the beginning of the event, we reserve the right, not to fulfill services if 100% of the invoice balance has not been received.

Once you confirm your package, we will send you an invoice payable online via PAYPAL or VENMO

A method accommodating Credit Cards/Debit Cards.

We will send you an invoice via text or email allowing you to pay online.

Notes: See Invoice for itemized service description.

- **One, up to three hours are needed to set-up equipment** prior to the event (dependent upon size of set-up) and a minimum of 60-90 minutes at the conclusion of the event in order to dismantlement and pack equipment.
- **A minimum of 10' x 10' area** of space will be provided by venue or client/undersigned for staging of disc jockey(s) equipment including speakers and lighting set-up. This space is exclusively designated for the equipment and members of DJ group. Please send floor plans of the establishment if available. Mark designated area for DJ's and available electrical outlets.
- **Electrical outlets shall be provided** by the venue or client/undersigned and is the undersigned's responsibility.
- **Parking fee(s)** for DJ's and it's members vehicles shall be paid by client/undersigned. Receipt for parking will be given to the undersigned if reasonable parking is not available during the event.

Cancellation Fee is 20% of Total Invoice (when reserved and notified 30 days or more, prior to reserved date. Email communication is required).

Cancellation Fee is 50% of Total Invoice or forfeit of deposit (when reserved and notified 30 days or less, prior to reserved date. Email communication is required).

Custom Order items for an event are non-refundable (example: monograms).

An overtime rate of \$100.00 per 30 minutes or a fraction thereof, shall be charged in addition to the agreed rate. Overtime rate shall be made payable immediately upon the conclusion of the event. We reserve the right to refuse services beyond contracted hours. ▪ \$100.00 charge on returned funds/check(s). In the event of a returned funds/check; Cash Paypal, or Venmo shall be the only of form payment. ▪ Undersigned is financially responsible for any damage(s) resulting in any person(s) / foreign object(s) coming in contact with any member(s) or equipment belonging to DJ group. ▪ Should the event be delayed or terminated at no fault of DJ's, the undersigned shall be liable for full payment of services rendered. We are not responsible for any delays in regards to establishment (i.e.: venue opening late, weather, etc.) We are also not responsible for any lack of service, if any portion of the itinerary is not completed properly.
